#### Location

The property is located within the London Borough of Hackney on the corner of Clarence Road and Cricketfield Road. The Mermaid lies roughly equidistant between Clapton (north) and Hackney (south) with Hackney Downs a short distance to the west. The local area comprises a mixture of commercial uses interspersed with residential accommodation.

The nearest station is Clapton (London Overground Line) which is located approximately 550 metres to the north of the property, providing frequent services to Liverpool Street in an average journey time of just under 15 minutes.

## **Description**

The premises comprises the ground floor and basement of a four-storey building.

The internal accommodation is summarised as follows: -

Ground Floor: Open plan trade area fitted with a central bar servery, perimeter seating,

disabled customer wc and storage areas.

Basement: Trade area, trade kitchen, a set of male and female customer wc's, cold beer store

and various ancillary storage areas.

Outside: External trade area to the front.

We are advised that the gross internal area of the ground floor and basement is approximately 1,991 sq ft (185 sq m).



## Site Plan




